### Terms and Conditions

The South Shore Folk Music Club (the “Club”) will review all applications. Decisions regarding instrument loans are subject to the discretion of the Club and are final.

- **Membership**
  - Applicant agrees to maintain membership in the Club during the instrument loan period.
- **Deposit**
  - \$50.00 required at time of instrument loan pickup.
- **Loan Period**
  - No loans shall be in effect during the period from approximately June 1 to September 14.
  - Instruments must be returned no later than the date of the last concert of the season.
  - The loan period shall be one month from the time of instrument loan pickup.
  - Renewals can be made by phone once a month for a total of three loan periods.
  - The Club retains the right to call in the loan at any time.
- **Contact Information**
  - Applicant agrees to notify the Instrument Loan Coordinator (Karen Haffner, 781-878-1683) of any change of address or phone number.
- **Instrument Condition**
  - Applicant agrees to return the instrument in the same condition it was at the start of the loan period.
  - Applicant agrees to pay for repair in the event the instrument is damaged.
  - Applicant agrees to notify the Club of the damage prior to having the instrument repaired.
  - Applicant agrees to pay for replacement in the event the instrument is stolen or damaged beyond repair.
  - The Club shall determine the instrument’s value.
  - Instruments must be picked up and returned at Club events.
